## **CIRCULAR LETTER**

NUMBER 15243 TAHUN 2020

## ABOUT REQUIREMENTS OF ARCHIPELAGO TOURISM VISIT TO BALI

The sanctity and harmony of Bali's nature and its contents have a noble value that must be maintained, so that the balance of nature, people and culture of Bali is created so that Bali still has a strong appeal, is loved, respected, and respected by the world community. In line with these noble values, tourism in Bali must prioritize health and quality **aspects that provide more protection, comfort and safety for tourists** visiting Bali during the COVID-19 pandemic. This is also in accordance with Circular Letter of Task Force for the Acceleration of Handling COVID-19 Number 9 of 2020 concerning Amendment to Circular Letter Number 7 of 2020 concerning Criteria and Requirements for Travel of Persons in the Adaptation Period of New Habits Towards a Safe and Productive Community COVID-19, dated June 26 2020

In this regard, it is deemed necessary to enact provisions regarding the requirements for Nusantara Tourists visiting Bali, as follows:

- 1. COVID-19 free by showing a Certificate of negative results of the PCR (*Polymerase Chain Reaction*) based swab test, the minimum *non-reactive rapid test* results from the authorized agency.
- 2. The validity period of a Certificate of negative results of a PCR-based swab test or the results of a *non-reactive rapid test* for visiting Bali is no later than 14 (fourteen) days after the Certificate is issued.
- 3. Travelers who have shown a Certificate of negative PCR-based swab test or *non-reactive* rapid test results that are still valid, are no longer required to carry out swab tests or rapid tests, unless they experience clinical symptoms of COVID-19.
- 4. Tourists who cannot show a Certificate of negative PCR-based swab test or *non-reactive* rapid test results are **obliged to take a PCR-based swab test or rapid test in Bali**.
- 5. Tourists whose results are **reactive rapid test**, are obliged to take the **PCR-based swab test** in Bali. While waiting for the results of the swab test, tourists undergo a quarantine process at a place determined by the Provincial Government of Bali.
- 6. Travelers who are positive for COVID-19 based on the results of the swab test will be treated at a health facility in Bali.
- 7. The cost of a swab test, *rapid test*, quarantine or health facility is the responsibility of the Tourist.
- Before departure to Bali, every Tourist is obliged to fill in the LOVEBALI Application.
   LOVEBALI Application Instructions can be accessed on the page https://lovebali.baliprov.go.id. Tourism accommodation businesses in Bali must ensure that every Tourist has filled out the LOVEBALI Application.

- 9. During carrying out tourist activities in Bali, tourists are obliged to implement the New Era of Bali Life Order Protocol in accordance with the provisions of the Provincial Government of Bali, namely:
  - a. use a mask / face shield;
  - b. wash your hands with soap and running water or use a hand sanitizer;
  - c. meet the requirements to maintain a minimum distance of 1 (one) meter when interacting and sitting;
  - d. implementing Clean and Healthy Behavior (PHBS);
  - e. covering the nose and mouth with a tissue or handkerchief when sneezing and coughing;
  - f. avoid using the hands to directly touch areas of the face, such as: eyes, nose and mouth;
  - g. undergo body temperature measurements;
  - h. clean personal items, such as *mobile phones*, glasses, bags, masks, and other items, with disinfectant liquid as needed; Willing to be examined by health workers in order to prevent the spread of COVID-19; and
  - j. avoid physical contact when greeting.
- 10. While in Bali, tourists are encouraged to activate the Global Positioning System (GPS) on *smartphones* for efforts to protect and protect tourists.
- 11. Tourists can submit complaints or problems while in Bali through the **LOVEBALI** Application.
- 12. Tourists are obliged to comply with the provisions in this Circular Letter. For tourists who violate will be subject to sanctions in accordance with statutory provisions.

This Circular Letter is thus to be understood and carried out with full awareness for the sake of our common good and safety. Thank you.
